





## Workflow of getting Agriculture services through e-LICENSING System




## Objective

E-Licensing system is a single window platform for facilitating the citizens to obtain hassle free QR coded license to deal with primary agri-inputs viz. Seed, Fertilizer and Insecticide in adherence to respective legislations and Rules which has been notified vide 35672/ A&FE 30.12.2019 and being operated through <https://odishaagrlicense.nic.in>. The licensing system renders G 2C & G 2B agricultural services corresponding to ORTPSA timeline.




## ▶ Building blocks & sub-areas are:

- Single window Service Delivery : The portal handles ten types of licenses required to deal seed, Fertilizer and insecticides along with three major applications viz; Apply, Renew and Amend
- G2C service delivery can be availed without any physical visit to the Government offices
- Minimizing Regulatory Compliance Burden & paperless application with minimum documentation for the applicants
- Online Inventory system for Monthly Progress report on sale and stock of the firms
- Government officials gets digital assistance to execute more task in less time
- Mandatory feed backs: To improvise the easy of online service delivery every applicants have provided mechanism to submit their feed back. In addition to that the applicant need to provide mandatory feedback for downloading their QR coded license or enrollment copy.
- Grievance Resolution: The grievance of the applicant are given in the feedback column in the portal which are addressed by the appropriate authority.
- Source certificate Issuance: The Distributer/ Dealer to choose the source (manufactures) online and the manufactures has to approve their distributer/ dealer online product wise.
- Tracking of Application Status: All the users (Applicant and the approval authority) can track the application at various stages and take necessary action as per the remarks.
- Payment gateway (iFMS) : The prescribed licensing fees are paid through e-challan /payment gateway integrated with iFMS system.
- QR Coded License: After approval by the licensing authority the QR coded license is generated this is self downloadable.
- Geo-Tagged Inspection: The location of stock/ sale point is being inspected by the inspection authority as per rule prior to issuance of license which is Geo-tagged.
- Suspension of license : The licensing authority suspend/ cancel the license online during enforcement process.




